Chamber briefed by Assemblymember Dymally on uninsured

The current political climate is conducive to working on a solution to reduce the number of uninsured and make health care affordable, said Assemblymember Mervyn Dymally, chair of the State Assembly Health Committee, at the Chamber's Health Care Committee meeting Friday. In the past year, 6.5 million Californians under the age of 65 were uninsured, Dymally said. In L.A. County, 25 percent of the population lacked insurance. The Health Care Committee also received an update on Martin Luther King-Harbor Medical Center and the homeless health initiative. Chamber updated on L.A.'s industrial land use policy and rent control measure

The Chamber's Land Use, Construction & Housing Committee heard from Don Spivack of the L.A. City Planning Department Thursday, on plans to update the city's [industrial land use policy](#). In considering the policy, the department is taking into account a number of issues, including the need for a balance of jobs and housing in the area, and that new housing in industrial zones increases land costs for new and expanding businesses. The committee agreed to write a letter of concern to the L.A. City Council regarding the Council's proposed revisions to the condominium conversion policy and rent control ordinances; and agreed to support the Hollywood Freeway Park Cap, which would create 24 acres of new green space.
